TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of November 9, 2021 in favor of Blaze Equipment, LLC, a Texas limited liability company (the "Company"), by The Huntington National Bank (successor by merger to TCF National Bank), in its capacity as administrative agent (in such capacity, the "Administrative Agent") for the lenders from time to time party to the Credit Agreement referred to in the Security Agreement (as defined below).

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement dated as of December 22, 2020 (the "Security Agreement") executed by the Company in favor of the Administrative Agent, the Company granted to the Administrative Agent, for the benefit of itself and the other Secured Parties, a security interest in all of the Company's right, title and interest in and to the trademark applications and registrations set forth on Schedule 1 attached hereto (collectively the "Trademarks");

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on December 22, 2020 at Reel/Frame 7143/0008.

WHEREAS, the Administrative Agent wishes to release its security interest in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates the Security Agreement and hereby terminates, cancels and releases any security interest it may have in the Trademarks.

The Administrative Agent shall take all further actions, and provide to the Company all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Company to more fully and effectively effectuate the purposes of this Release. The Company is hereby authorized to file and record this Release with the appropriate governmental agency or authority as evidence of the release of security interest granted hereunder.
