TRADEMARK SECURITY AGREEMENT SUPPLEMENT



Each Grantor hereby confirms the grant to the Agent, for the benefit of each member of the Lender Group and the Bank Product Providers, set forth in the Trademark Security Agreement of, and does hereby grant to the Agent, for the benefit of each member of the Lender Group and the Bank Product Providers, a continuing security interest in all of such Grantor’s right, title and interest in and to all Trademark Collateral to secure the Secured Obligations, in each case whether now or hereafter existing or in which such Grantor now has or hereafter acquires an interest and wherever the same may be located. Each Grantor hereby agrees that the attached Supplement to Schedule I to the Trademark Security Agreement shall constitute part of and an addition to Schedule I to the Trademark Security Agreement. Each Grantor hereby represents and warrants that the Trademarks set forth on Schedule I to the Trademark Security Agreement (as supplemented hereby) includes all of the registered Trademarks owned by such Grantor other than any Trademark that has been abandoned, is no longer in use by such Grantor or which, after the date hereof, will no longer be utilized by such Grantor.
