## CONFIRMATORY TRADEMARK ASSIGNMENT

This Confirmatory Trademark Assignment (“Assignment”), effective as of August 25, 2021 (the “Effective Date”), is made from naviHealth, Inc., a Delaware corporation (“Assignor”), to Curaspan Health Group, Inc., a Delaware corporation (“Assignee”).

WHEREAS, as of the Effective Date, Assignor was the owner of the trademarks identified on Exhibit A hereto (collectively, the “Marks”), together with all goodwill and common law rights associated therewith, and applications and registrations therefor, including the U.S. trademark registrations identified on Exhibit A;

WHEREAS, on September 8, 2021, a document was recorded in error with the assignment division of the United States Patent and Trademark Office at Reel 7415 / Frame 0532, as the document did not explicitly state that the goodwill associated with the Marks is assigned; and

WHEREAS, in order to effect the ownership of rights as described above and to facilitate recordation and registration of Assignee’s rights in the Marks, the parties have agreed to enter into this Assignment;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignment. Nunc pro tunc effective as of the Effective Date, Assignor hereby sells, assigns, and transfers to Assignee all of Assignor’s worldwide rights, title, and interests in and to the Marks, together with the goodwill of the business symbolized thereby and associated therewith, including without limitation the U.S. registrations identified on Exhibit A and any and all other applications and registrations for the Marks, all common law rights in and to the Marks, and all rights to sue for past, present, and future infringement and misappropriation of the Marks (collectively, the “Assigned Rights”).

2. Recordation. Assignor hereby authorizes and requests any official whose duty it is to register and record ownership in trademark registrations, to record Assignee as the assignee and owner of any and all of the Assigned Rights.

3. Successors and Assigns. This Assignment will be binding upon and enforceable against Assignor and its successors and assigns and will inure to the benefit of and be enforceable by Assignee and its successors and assigns.

4. Counterparts. This Assignment may be executed in one or more counterparts, each of which will be deemed an original but all of which together will constitute one and the same instrument. An executed signature page of this Assignment delivered by facsimile or PDF transmission will be as effective as an original executed signature page.
