## TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT is effective as of this 10<sup>th</sup> day of November, 2021 by and between Jim Beam Brands Co., a corporation organized and existing under the laws of the State of Delaware, having a place of business at 222 W. Merchandise Mart Plaza, Suite 1600, Chicago, Illinois 60654, (hereinafter “**Assignor**”), and GT Spirits, Inc., a corporation organized and existing under the laws of the State of Delaware, having a place of business at 862 E. 2nd Street, Suite 6, Boston, Massachusetts, 02127 (hereinafter “**Assignee**”).

WHEREAS, Assignor is the owner of the trademarks identified in Exhibit A (the “**Trademarks**”);

WHEREAS, Assignee desires to acquire Assignor’s entire interest in the Trademarks, together with the goodwill of the business and the right to recover for damages and profits for past infringements thereof.

NOW, THEREFORE, to all whom it may concern be it known that for and in consideration of good and valuable consideration, the receipt of which is hereby acknowledged, Assignor and Assignee, for themselves, their successors, assigns and legal representatives, have and hereby do covenant, bargain and agree as follows:

1. Assignment. Assignor hereby sells, assigns, transfers and conveys to Assignee, its successors, assigns and legal representatives, the entire right, title and interest it has in and to the Trademarks, together with the goodwill of the business, the right to sue for and collect damages and other recoveries, and all rights to initiate proceedings before government and administrative bodies.


2. Authorization. Assignor authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any other official throughout the world whose duty is to register and record ownership in trademark registrations and applications for registration of trademarks, to record Assignee as the assignee and owner of any and all of Assignor’s rights in the Trademarks.

4. Miscellaneous. This Agreement shall be construed in accordance with the laws of the State of Delaware, without regard to conflicts of laws provisions thereof.

**IN WITNESS WHEREOF**, Assignor has caused this Agreement to be executed as a sealed instrument by its duly authorized representative, effective as of the date first written above.
