**CONFIRMATORY RELEASE OF SECURITY INTEREST IN TRADEMARKS**

The Lien Holder agrees, at Trademark Owner's expense and request, to take all lawful acts which any Trademark Owner or assignee of the Trademarks may deem advisable or necessary in order to render this release fully effective and to make this release of record in the U.S. Patent and Trademark Office and corresponding government offices throughout the world where Lien Holder has recorded its security interests, and such other government offices as Trademark Owner may select, including without limitation, execution of lawful documents.
