**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This Termination and Release of Security Interest in Intellectual Property (“Release”) is made as of November 8, 2021 by **SILICON VALLEY BANK**, a California corporation (“Bank”) in favor of **WELLTOK, INC.**, a Delaware corporation with an address at 3002 Brighton Boulevard, Unit 743, Denver, Colorado 80216, as successor-in-interest to **VOXIVA, INC.**, (the “Grantor”) and its successors, assign and legal representatives. Capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, the Grantor entered into a certain intellectual property security agreement dated June 26, 2019 (the “IP Security Agreement”) with Bank, notice of which was recorded on July 2, 2019 at the United States Patent and Trademark Office at Reel 6684, Frame 0766 with respect to the Trademarks, and and on June 27, 2019 at Reel 049623, Frame 0699 with respect to the Patents.

WHEREAS, Grantor granted the Bank, under the terms of the IP Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Bank, in and to all of the Intellectual Property Collateral, including without limitation the Trademarks listed in **Schedule A** and the Patents listed in **Schedule B**.

WHEREAS, the Bank has agreed to terminate and release its security interest in all such Intellectual Property Collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and in consideration of the foregoing and intending to be legally bound, the Bank, for itself and on behalf of the lenders in association with the Security Interest, hereby (i) terminates the IP Security Agreement, (ii) releases, terminates and discharges any and all liens, security interests, right, title and interest in, to, and under the Intellectual Property Collateral of the Grantor, and (iii) assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest, together with the goodwill of the business symbolized thereby.
