BETWEEN:-

- (1) **BARCLAYS BANK PLC** (Company number 01026167) whose registered office is at 1 Churchill Place, London, E14 5HP (the "**Bank**"); and
- (2) **ER TRAVEL SERVICES LTD (IN ADMINISTRATION)** (Company number, 06895847) whose registered office is at Liver Building, 9th Floor Liver Building, Liverpool, Merseyside, L3 1HU (the "**Company**") acting by its Joint Administrators Peter David Dickens of PricewaterhouseCoopers LLP, 1 Hardman Square, Manchester, M3 3EB and Ross David Connock of PricewaterhouseCoopers LLP, 2 Glass Wharf, Bristol, BS2 0FR respectively (together the "**Administrators**").

WHEREAS:-

- (A) By the debenture short particulars of which are set out in Schedule 1 hereto (the "**Security**"), the Company charged certain of its property and assets to the Bank as security for the payment and discharge of all monies, obligations and liabilities therein covenanted to be paid and discharged.
- (B) The Company (acting by its Administrators) wishes to sell the assets more particularly described in Schedule 2 hereto (the "**Assets**") to ER Capital Ltd (No. 08272510) (the "**Buyer**") free from the Security and the Bank has agreed to execute this Deed by way of acknowledgment of the release of the Assets from the charges and securities contained in the Security.

IT IS AGREED as follows:-

1. The Bank hereby absolutely, irrevocably and unconditionally releases the Assets from all mortgages, charges, liens, encumbrances and other securities created by the Security and all claims and demands thereunder and (insofar as may be necessary) reassigns all (if any) of the Bank's right, title and interest in the Assets to the Company to hold free from all such mortgages, charges, liens, encumbrances and other securities.
2. Nothing contained in this Deed shall prejudice or affect the security of the Bank under the Security in respect of the remaining property and assets charged thereunder other than the Assets or the obligations of the Company or rights of the Bank under the Security and, save in respect of the Assets, the Security shall remain in full force and effect.
3. The Bank agrees that it will (at the request and cost of the Company) do all things and execute any further documents or deeds as the Company may reasonably require for the purpose of giving effect to this Deed.
4. The Bank makes and gives no representations, warranties or covenants in relation to the Assets, except that it has not itself created any encumbrance over them which is not released, re-assigned or discharged under this Deed.
5. This Deed may be executed in any number of counterparts and by each of the parties as separate counterparts, each of which, when executed and delivered, shall be deemed to be an original but all the counterparts together shall constitute one and the same agreement.
6. This Deed does not confer any rights on any person or party (other than the parties to this Deed, and the Buyer) under the Contracts (Rights of Third Parties) Act 1999.
7. This Deed and any non-contractual obligations arising out of or in connection with it are governed by English law.


