U.S. TRADEMARK APPLICATION ASSIGNMENT

This U.S. TRADEMARK APPLICATION ASSIGNMENT (“Assignment”), effective as of the 12th day of November, 2021 is made and entered into by and between Jersey Mike’s Franchise Systems, Inc. (“Assignor”) and A Sub Above, LLC (“Assignee”). Assignor and Assignee are referred to individually as a “Party” and collectively as the “Parties”.

WHEREAS, Assignor is the record owner of the United States trademark application identified in the attached Schedule A (the “Trademark Application”);

WHEREAS, pursuant to that certain Contribution Agreement by and between the Parties dated as of December 23, 2019, Assignor has assigned to Assignee all rights, title, and interests in and to the Trademark Application, and the Parties wish to record such assignment;

1. Assignor hereby assigns and transfers to Assignee, its successors and permitted assigns, and Assignee hereby accepts and receives, all of Assignor’s entire rights, title, and interests in, to and under the Trademark Application, including, without limitation, (a) the goodwill of the business symbolized by and associated with the Trademark Application; and (b) any and all legal actions and rights and remedies at law or in equity for past, present, or future infringements, dilutions, or other violations of the Trademark Application, including without limitation the right to sue for, collect, and retain all damages, profits, proceeds, and all other remedies associated therewith.
2. Assignor hereby authorizes and requests the United States Patent and Trademark Office to record Assignee as the assignee and owner of the Trademark Application.
3. This Assignment will be binding upon and enforceable against Assignor and Assignor’s respective successors and assigns and will inure to the benefit of and be enforceable by Assignee and its successors and assigns.
4. This Assignment will be governed by, and construed and enforced in accordance with, the substantive laws of the State of New York, without regard to its principles of conflicts of laws. This Assignment may not be supplemented, altered, or modified in any manner except by a writing signed by both Parties.
5. This Assignment may be executed in any number of counterparts, and by the Parties in separate counterparts, each of which will be deemed an original for all purposes and all of which together will constitute one and the same instrument.
