RELEASE OF TRADEMARK SECURITY INTERESTS dated as of November 12, 2021 (this "Release"), by BANK OF AMERICA, N.A., as administrative agent (the "Administrative Agent"). Capitalized terms used herein and not otherwise defined herein shall have the meanings assigned to such terms in the Credit Agreement or the Security Agreements, as applicable.

A. Reference is made to (i) the Credit Agreement dated as of May 22, 2012 (as amended, modified, extended, restated, renewed, replaced, or supplemented from time to time, the "Credit Agreement"), among Fanatics, Inc. (the "Grantor"), the Guarantors party thereto, the Lenders party thereto and the Administrative Agent, (ii) the Security and Pledge Agreement dated as of May 22, 2012 (as amended, modified, extended, restated, renewed, replaced, or supplemented from time to time, the "Agreement"), among the Grantors party thereto and the Administrative Agent and (iii) the Notice of Grant of Security Interest in Trademarks dated as of May 22, 2012, between the Grantor and the Administrative Agent (the "Notice of Grant of Security Interest" and, together with the Agreement, the "Security Agreements").

B. Pursuant to the Security Agreements, the Grantor granted to the Administrative Agent, for the ratable benefit of the Secured Parties, a continuing security interest in and continuing lien upon the trademarks and trademark applications of the Grantor set forth on Schedule 1 hereto (collectively, the "Trademark Collateral"), which security interests were recorded with the United States Patent and Trademark Office on June 6, 2012 at Reel/Frame 4796/0318.

C. Pursuant to the Payoff Letter dated as of September 24, 2013, between the Grantor and the Administrative Agent, the Administrative Agent agreed to release any and all security interests it may have in the Trademark Collateral pursuant to the Security Agreements.


Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent does hereby release, relinquish and discharge any and all security interests it has against the Trademark Collateral. The Administrative Agent agrees to make filings with the United States Patent and Trademark Office and other necessary filings, in each case, reasonably requested by the Grantor and at the expense of the Grantor, to evidence the release and termination of the Administrative Agent's security interests in the Trademark Collateral.
