ADDENDUM

to

INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Addendum (the "Addendum") to the Intellectual Property Assignment Agreement, dated August 12, 2020 (hereinafter referred to as the "Agreement") is entered into by and between:

**John Varvatos Apparel, Corp.**, a Delaware corporation, **John Varvatos Enterprises, Inc.**, a Delaware corporation, **Lion/Hendrix Corp.**, a Delaware corporation (hereinafter individually referred to as the "Seller" and collectively referred to as the "Sellers"); and

**JV Asset Holdco LLC**, a Delaware limited liability company (hereinafter referred to as the "Designated Purchaser").

Capitalized terms used but not otherwise defined herein have the meanings ascribed to such terms in the Agreement.

WHEREAS, Lion/Hendrix Cayman Limited, a Cayman Islands exempted limited company ("LHCL"), and the Sellers entered into that certain Amended and Restated Asset Purchase Agreement, dated as of July 23, 2020 and effective as of August 12, 2020 (as amended, restated, modified or otherwise supplemented, the "Purchase Agreement"), pursuant to which LHCL designated that the Designated Purchaser would acquire, among other things, all of right, title and interest of the Sellers in, to and under the Seller Intellectual Property, as defined and set forth in the Agreement and as reproduced on Appendix A hereto;

WHEREAS, on August 12, 2020, in connection with and in furtherance of the Purchase Agreement, the Sellers and the Designated Purchaser entered into the Agreement;

WHEREAS, pursuant to Section 12 of the Agreement, the Agreement may be amended or modified by an instrument in writing signed on behalf of each Party to the Agreement; and

WHEREAS, the Sellers and the Designated Purchaser desire to amend the Agreement as set forth herein to clarify Sellers' sale, transfer, assignment, conveyance and delivery to the Designated Purchaser of all goodwill associated with or symbolized by, the Trademarks included in the Seller Intellectual Property, consistent with the Parties' intent and the purpose of the Agreement and the Purchase Agreement.

NOW, THEREFORE, in consideration of the premises and the mutual covenants and the agreements set forth herein, in the Agreement and in the other ancillary documents, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Sellers and the Designated Purchaser, intending to be legally bound, hereby agree as follows:

Section 1. Amendment. Section 1 of the Agreement is hereby amended and restated in its entirety as follows (bold and underlined language added to evidence changes):

Section 1. Assignment. Effective as of the Closing, the Seller hereby irrevocably sells, transfers, assigns, conveys and delivers to the Designated Purchaser, free and clear of all Encumbrances of any and every kind, nature and description, other than Permitted Post-Closing Encumbrances, all of such Seller's right, title and interest in, to and under all of the Seller Intellectual Property, together with all goodwill associated with or symbolized by, the

Trademarks included in the Seller Intellectual Property, including (a) all rights to sue for and recover and retain damages for present, past and future infringement, misappropriation or other violation thereof, and (b) the Registered Intellectual Property set forth on Schedule A; for clarification, with respect to each of the United States intent-to-use trademark applications set forth on Schedule A, the transfer of such application accompanies the transfer of Seller's business, or that portion of the business to which the trademark application pertains, and that business is ongoing and existing. Effective as of the Closing, the Designated Purchaser hereby purchases, accepts and acquires from each Seller, as applicable, free and clear of any and all Encumbrances of any and every kind, nature and description, other than Permitted Post-Closing Encumbrances, all of such Seller's right, title and interest in, to and under the Seller Intellectual Property, together with all goodwill associated with or symbolized by, the Trademarks included in the Seller Intellectual Property. For the avoidance of doubt, notwithstanding any provision in the Purchase Agreement or this Agreement to the contrary, none of the Sellers makes any representations or warranties in respect to its ownership in any "John Varvatos Records" trademark or the "johnvarvatosrecords.com" domain name.

Section 2. Binding Effect of Agreement. Except as expressly modified and amended as set forth in this Addendum, the Agreement remains in full force and effect, enforceable in accordance with its terms. The terms and provisions of Sections 2 through 13 of the Agreement are incorporated herein by reference as if set forth herein in their entirety and shall apply *mutatis mutandis* to this Addendum.

IN TESTIMONY WHEREOF, the Sellers and Designated Purchaser have caused this Addendum to the Intellectual Property Assignment Agreement, dated August 12, 2020 to be executed on their behalf by their legal representatives.

## INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT, dated as of August 12, 2020 (this “**Agreement**”), is entered into by and among John Varvatos Apparel, Corp., a Delaware corporation (“**JVA**”), John Varvatos Enterprises, Inc., a Delaware corporation (“**JVE**”), Lion/Hendrix Corp., a Delaware corporation (“**LHC**” and together with JVA and JVE, in their capacities as debtors and debtors in possession, the “**Sellers**”), and JV Asset Holdco LLC, a Delaware limited liability company (the “**Designated Purchaser**,” and, together with the Sellers, each a “**Party**” and collectively the “**Parties**”). Capitalized terms used but not otherwise defined herein have the meanings ascribed to such terms in the Purchase Agreement (as defined below).

### W I T N E S S E T H:

WHEREAS, Lion/Hendrix Cayman Limited, a Cayman Islands exempted limited company (“**LHCL**”), and the Sellers have entered into that certain Amended and Restated Asset Purchase Agreement, dated as of July 23, 2020 and effective as of May 6, 2020 (as amended, restated, modified or otherwise supplemented, the “**Purchase Agreement**”), pursuant to which LHCL has designated that the Designated Purchaser will acquire, among other things, all of right, title and interest of the Sellers in, to and under the Seller Intellectual Property; and

WHEREAS, the Sellers and the Designated Purchaser now desire to carry out the intent and purpose of the Purchase Agreement and the designation referenced above by the Sellers’ and the Designated Purchaser’s execution and delivery of this Agreement evidencing and effecting the sale, transfer, assignment, conveyance and delivery to the Designated Purchaser of the Seller’s right, title and interest in, to and under the Seller Intellectual Property.

NOW, THEREFORE, in consideration of the premises and the mutual covenants and the agreements set forth herein, in the Purchase Agreement and in the other Ancillary Documents, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties, intending to be legally bound, hereby agree as follows:

Section 1. Assignment. Effective as of the Closing, each Seller hereby irrevocably sells, transfers, assigns, conveys and delivers to the Designated Purchaser, free and clear of all Encumbrances of any and every kind, nature and description, other than Permitted Post-Closing Encumbrances, all of such Seller’s right, title and interest in, to and under all of the Seller Intellectual Property, including (a) all rights to sue for and recover and retain damages for present, past and future infringement, misappropriation or other violation thereof, and (b) the Registered Intellectual Property set forth on Schedule A. Effective as of the Closing, the Designated Purchaser hereby purchases, accepts and acquires from each Seller, as applicable, free and clear of any and all Encumbrances of any and every kind, nature and description, other than Permitted Post-Closing Encumbrances, all of such Seller’s right, title and interest in, to and under the Seller Intellectual Property. For the avoidance of doubt, notwithstanding any provision in the Purchase Agreement or this Agreement to the contrary, none of the Sellers makes any representations or warranties in respect to its ownership in any “John Varvatos Records” trademark or the “johnvarvatosrecords.com” domain name.



Section 2. Recordation. The Sellers hereby authorize and request the Commissioner of Patents and Trademarks of the United States and the Office of the Register of Copyrights of the United States, and any official of any other jurisdiction or organization whose duty is to issue any applicable Intellectual Property or any legal equivalent thereof, to record and register the Designated Purchaser as the assignee and owner of all right, title and interest in, to and under the applicable Seller Intellectual Property.

Section 3. Further Assurances. Upon the request of the Designated Purchaser, each Seller shall promptly execute any other documents and take any other actions reasonably required to give the Designated Purchaser the full benefit of this Agreement, the Transactions and the assignments set forth in Section 1, including any such documents required to perfect and record such assignments in any applicable filing jurisdictions.

Section 4. No Third Party Beneficiaries. This Agreement is for the sole and exclusive benefit of the Designated Purchaser and the Sellers and their respective successors and permitted assigns, and nothing herein, express or implied, is intended or shall be construed to confer upon any other Person any legal or equitable right, remedy, claim, reimbursement or cause of action of any nature whatsoever under or by reason of this Agreement.

Section 5. Successors and Assigns. This Agreement shall be binding upon and shall inure to the benefit of the Parties and their respective successors and assigns.

Section 6. Subject to Purchase Agreement. The scope, nature, and extent of the Seller Intellectual Property are expressly set forth in the Purchase Agreement. Nothing contained in this Agreement shall itself change, amend, extend or alter (nor shall it be deemed or construed as changing, amending, extending or altering) the terms or conditions of the Purchase Agreement in any manner whatsoever. This Agreement does not create or establish liabilities or obligations not otherwise created or existing under or pursuant to the Purchase Agreement. In the event of any inconsistency between the Purchase Agreement and this Agreement, the provisions of the Purchase Agreement shall govern and control. The Parties acknowledge and agree that the representations, warranties, covenants, agreements, conditions and indemnities contained in the Purchase Agreement will not be superseded hereby but will remain in full force and effect to the full extent provided therein.

Section 7. Governing Law. This Agreement, and all Actions (whether in contract, tort or statute) that may be based upon, arise out of or relate to this Agreement, or the negotiation, execution or performance of this Agreement, shall be governed by, and enforced in accordance with, the Laws of the State of Delaware, including its statutes of limitations, without giving effect to any borrowing statute or applicable principles of conflicts of law to the extent that the application of the laws (including statutes of limitation) of another jurisdiction (whether of the State of Delaware or any other jurisdiction) would be required thereby.

Section 8. Submission to Jurisdiction. Each Party irrevocably and unconditionally consents to submit to the exclusive jurisdiction of the Bankruptcy Court for any litigation arising out of or relating to this Agreement and the transactions contemplated thereby (and agrees not to commence any litigation relating thereto except in the Bankruptcy Court), and waives any objection to the laying of venue of any such litigation in the Bankruptcy Court. To the

extent the Bankruptcy Court declines, or is otherwise unable to, exercise jurisdiction, then the Parties agree that the state or federal courts in the County of New Castle, State of Delaware, shall have jurisdiction.

Section 9. WAIVER OF JURY TRIAL. EACH PARTY IRREVOCABLY AND UNCONDITIONALLY WAIVES TO THE FULLEST EXTENT PERMITTED BY LAW ANY RIGHT IT MAY HAVE TO A TRIAL BY JURY WITH RESPECT TO ANY ACTION BASED UPON, ARISING OUT OF OR RELATING TO THIS AGREEMENT OR THE TRANSACTIONS CONTEMPLATED HEREBY OR BY THE PURCHASE AGREEMENT. EACH PARTY ACKNOWLEDGES AND CERTIFIES (I) THAT NO REPRESENTATIVE, AGENT OR ATTORNEY OF ANY OTHER PARTY HAS REPRESENTED, EXPRESSLY OR OTHERWISE, THAT SUCH OTHER PARTY WOULD NOT, IN THE EVENT OF ANY ACTION OR PROCEEDING, SEEK TO ENFORCE THE FOREGOING WAIVER, (II) IT UNDERSTANDS AND HAS CONSIDERED THE IMPLICATIONS OF THIS WAIVER, (III) IT MAKES THIS WAIVER VOLUNTARILY AND (IV) IT HAS BEEN INDUCED TO ENTER INTO THIS AGREEMENT, THE PURCHASE AGREEMENT AND THE OTHER ANCILLARY DOCUMENTS AND THE TRANSACTIONS CONTEMPLATED HEREBY AND THEREBY, AMONG OTHER THINGS, THE MUTUAL WAIVERS AND CERTIFICATIONS SET FORTH IN THIS SECTION 9 AND IN SECTION 8.9(C) OF THE PURCHASE AGREEMENT.

Section 10. Absolute Assignment. The Parties intend that the assignments effected by this Agreement shall constitute absolute and unconditional assignments.

Section 11. Entire Agreement. This Agreement, the Purchase Agreement and the other Ancillary Documents contain and constitute the entire agreement of the Parties with respect to the subject matter hereof and supersede all prior negotiations, agreements and understandings, whether written or oral, of the Parties.

Section 12. Amendment, Waiver and Termination. This Agreement may not be amended, modified or waived except by an instrument in writing signed on behalf of each Party.




