FORECLOSURE ASSIGNMENT OF TRADEMARKS

THIS FORECLOSURE ASSIGNMENT OF TRADEMARKS is entered into as of October 30, 2020, by and among Artissimo Designs LLC, a Delaware limited liability company ("Assignor") as assignor, by and through ECP Investco II LLC, a Delaware limited liability company ("Secured Party"), as secured party, and Artisan Homes LLC, a Delaware limited liability company ("Assignee"), as assignee.

WITNESSETH:

WHEREAS, Assignor previously entered into that Second Amended and Restated Secured Line of Credit Note dated as of October 23, 2015, in favor of Secured Party (the "Security Agreement"), whereby Assignor granted a security interest to Secured Party in and to certain trademark applications and registrations set forth in SCHEDULE A of this Assignment (the "Trademarks");

WHEREAS, Assignor defaulted in connection with its obligations to Assignee under the Security Agreement;

WHEREAS, Assignee has exercised a post-default remedy with respect to the Trademarks by conducting a public foreclosure sale of the Trademarks on the date hereof, pursuant to and in accordance with the provisions of Uniform Commercial Code § 9-610 as enacted and adopted by the State of Colorado (the "Foreclosure Sale"); and

WHEREAS, Secured Party was the lawful purchaser of the Trademarks at the Foreclosure Sale and has designated Assignee as its designee to receive title to the Trademarks; and

NOW THEREFORE, for good and valuable consideration, the receipt, sufficiency and adequacy of which are hereby acknowledged:

Assignor, by and through Secured Party, as a secured party holding a security interest in and to the Trademarks, hereby sells, assigns, and transfers to Assignee, its successors, and assigns, the entire right, title, and interest of Assignor throughout the world in and to the Trademarks, including any and all goodwill of the business relating thereto, general intangibles, and claims, powers, privileges, benefits and remedies relating to the Trademarks, as well as all products and proceeds of the Trademarks and/or any of the foregoing items.

This Assignment is deemed a transfer statement within the meaning of Uniform Commercial Code § 9-619, as enacted and adopted in the State of Colorado.

THIS ASSIGNMENT IS MADE WITHOUT ANY WARRANTY, EXPRESS OR IMPLIED, AS TO ANY MATTER WHATSOEVER, INCLUDING, BUT NOT LIMITED TO, WARRANTIES REGARDING QUALITY, CONTENT, CONDITION, TITLE, POSSESSION, MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, QUIET ENJOYMENT OR THE LIKE. ASSIGNEE IS ACQUIRING ASSIGNOR'S RIGHTS TO THE TRADEMARKS IN AN "AS IS" AND "WHERE IS" CONDITION, WITH ALL FAULTS AND SUBJECT TO ANY ENCUMBRANCES SENIOR TO SECURED PARTY'S SECURITY INTEREST AND/OR NOT OTHERWISE EXTINGUISHED BY THE SALE. IN NO EVENT SHALL SECURED PARTY OR ASSIGNEE BE LIABLE FOR ANY DIRECT, INDIRECT, INCIDENTAL, OR CONSEQUENTIAL DAMAGES IN CONNECTION WITH THIS ASSIGNMENT.

This Assignment is binding on the assigns, representatives, and successors of Assignor and extends to the successors, assigns, and nominees of Assignee.
