## TRADEMARK ASSIGNMENT

This Agreement is entered into freely by and between LuvUrGut, LLC, a Florida limited liability company with an address at 2582 Maguire Rd #257 Ocoee FLORIDA 34761 (“Assignor”) and KG PHYSIO LTD, a private company incorporated in England and Wales with an address at Wisteria Grange Barn, Pikes End, Pinner, Middlesex, England, HA5 2EX (“Assignee”).

WHEREAS, Assignor is the owner of the trademarks LUVURGUT, HAUL’A, THE WORLD’S BEST, and EARTH’S PEARL and U.S. Registration Nos. (respectively) 6,397,084, 5,512,920, 5,084,059, and 4,761,986 representing the rights in said marks (the “Trademarks”) and;

WHEREAS, Assignee wishes to acquire the entire rights, title, and interest in the Trademarks in perpetuity;

NOW, for good and valuable consideration the receipt of which is hereby confirmed, the parties agree as follows:

1. Assignment. Assignor does hereby irrevocably assign to Assignee all rights, title, and interest (including, but not limited to, all registration rights with respect to the Trademarks and all goodwill), in and to the Trademarks.
2. Representations and Warranties. Assignor represents and warrants to Assignee:
  - (a) Assignor has the right, power and authority to enter into this Agreement;
  - (b) Assignor is the exclusive owner of all right, title and interest, including all intellectual property rights, in the Trademarks;
  - (c) The Trademarks are free of any liens, security interests, encumbrances or licenses;
  - (d) The Trademarks do not infringe the rights of any person or entity;
  - (e) There are no claims, pending or threatened, with respect to Assignor's rights in the Trademarks;

(f) This Agreement is valid, binding and enforceable in accordance with its terms in all jurisdictions pertaining hereto; and

(g) Assignor is not subject to any agreement, judgment or order inconsistent with the terms of this Agreement.

3. Entire Agreement. This Agreement contains the entire understanding and agreement between the parties hereto with respect to its subject matter and supersedes any prior or contemporaneous written or oral agreements, representations or warranties between them respecting the subject matter hereof.
