## TRADEMARK ASSIGNMENT

WHEREAS, Edgar Alexander Barrera is an individual residing in Florida with an address at 10 Castania Ct., St. Augustine, Florida 32086 (“Assignor”);

WHEREAS, Assignor owns federal trademark Registration No. 3,662,484 for THE NATIONAL POLICE GAZETTE THE LEADING ILLUSTRATED SPORTING JOURNAL IN AMERICA & Design for “magazines in the field of current events and sports,” in Class 16 and “publication of magazines; newspaper publication; newspaper publishing,” in Class 41, which is referred to herein as the “Registration” while the trademark shown therein is referred to as the “Trademark”;

past, present, or future infringements, dilution, or other damage or injury to the Trademark or the Registration therefor, to be held and enjoyed by Assignee, its successors, and its assigns to the same extent that such would have been held and enjoyed by Assignor has such assignment not been made.

Assignor covenants that it has the full right and power to convey the entire interest herein assigned and has not executed and shall not hereafter execute any document in conflict with this assignment. Assignor agrees to execute and deliver, at the reasonable request of Assignee, all papers, instruments, and assignments, and to perform any other reasonable acts the Assignee may require in order to vest all of Assignor's rights, title, and interest in and to the Trademark and the Registration in the Assignee and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by the Assignee to the extent such evidence is within Assignor's possession, custody, or control. This assignment shall be effective as of the latest date shown below.
