**2. Third Party Rights**

2.1 A person who is not a party to this agreement has no rights (and the parties hereby exclude any such rights) under the Contracts (Rights of Third Parties) Act 1999 (the "Act") to enforce any term of this agreement but this does not affect any third party right or remedy which exists or is available apart from the Act.


**3. Governing Law and Jurisdiction**

4.1 This agreement may be executed in counterparts, each of which, when executed, is an original, but both counterparts taken together will constitute one document. This


agreement will not take effect until it has been executed by all parties. This agreement may be validly exchanged by email.
