RELEASE OF FIRST LIEN SECURITY INTEREST IN TRADEMARKS

This RELEASE OF FIRST LIEN SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of November 17, 2021, is made by Bank of America, N.A., as Administrative Agent (in such capacity, the “Administrative Agent”) in favor of Southern Graphics Inc., a Delaware corporation with a place of business in Sandston, VA (“Grantor”). Capitalized terms not defined herein shall have the meaning ascribed to them, directly or by reference, in the Trademark Security Agreement (as defined below).

WHEREAS, the Grantor, together with the other grantors party thereto, executed and delivered that certain Amended and Restated First Lien Pledge and Security Agreement, dated as of December 8, 2017, in favor of the Administrative Agent (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Pledge and Security Agreement”);

WHEREAS, pursuant to the Pledge and Security Agreement, the Grantor executed and delivered that certain First Lien Trademark Security Agreement, dated December 8, 2017 in favor of the Administrative Agent (the “Trademark Security Agreement”), which was recorded in the United States Patent and Trademark Office on December 11, 2017 at Reel/Frame 6225/0087;

WHEREAS, pursuant to the Pledge and Security Agreement and the Trademark Security Agreement, the Grantor granted to the Administrative Agent, for the benefit of the Secured Parties, a security interest (the “Security Interest”) in all of the following property then or at any time thereafter owned by the Grantor or in which the Grantor then had or at any time thereafter acquired any right, title or interest: (i) all U.S. federal and state and foreign trademarks, trade names, trade dress, corporate names, company names, business names, fictitious business names, trade styles, service marks, certification marks, collective marks, logos and other source or business identifiers, designs and general tangibles of a like nature, all registrations and recordings thereof, and all applications in connection therewith, whether in the United States Patent and Trademark Office or in any similar office or agency of the United States or any other country or any political subdivision thereof, and all common-law rights related thereto, including, without limitation, any of the foregoing referred to on Schedule A, and all rights corresponding thereto throughout the world, (ii) all of the goodwill of the business connected with the use of and symbolized by the foregoing, (iii) all extensions and renewals of the foregoing, (iv) the right to sue or otherwise recover for any past, present and future infringement, dilution or other violation of any of the foregoing or for any injury to goodwill, (v) all Proceeds of the foregoing, including, without limitation, license fees, royalties, income, payments, claims, damages, and proceeds of suit now or hereafter due and/or payable with respect thereto, (vi) and all other rights of any kind accruing thereunder or pertaining thereto throughout the world (the “Trademark Collateral”), and

WHEREAS, Grantor has requested that the Administrative Agent now terminate and release its Security Interest in the Trademark Collateral.

NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration the receipt and adequacy of which are hereby acknowledged, the Administrative

Agent hereby (i) terminates the Trademark Security Agreement, (ii) terminates and releases the Security Interest in the Trademark Collateral, and (iii) re-assigns to the Grantor any right, title or interest it may have in the Trademark Collateral, in each case without recourse to, or representation or warranty by, the Administrative Agent.

Grantor (and any successor to Grantor, including any person or entity hereafter holding any right, title or interest in and to the Trademark Collateral) is hereby authorized to record this Release with the United States Patent and Trademark Office, at Grantor's sole cost and expense.
