TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT (this “**Release**”) is made as of June 30, 2021, by BANK LEUMI USA, a New York corporation, having a place of business at 350 Madison Avenue, New York, NY 10017 (the “**Secured Party**”), in favor of SOCIUS INSURANCE SERVICES, INC., a California corporation, (the “**Grantor**”). Capitalized terms shall have the meanings assigned to such terms in the Agreement described below.

WHEREAS, Secured Party and Grantor were parties to that certain Trademark Security Agreement, dated December 27, 2018 (the “**Agreement**”), executed by Grantor in favor of the Secured Party and recorded with the United States Patent and Trademark Office on December 27, 2018, in Reel/Frame 6510/0396, pursuant to which the Grantor granted a security interest in certain Trademark Collateral, including, without limitation, the Trademarks set forth in Schedule 1 attached hereto.

WHEREAS, Grantor has requested that Secured Party releases its security interests in and lien on the Trademark Collateral and reassign the same to the Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby releases, terminates and discharges its security interest in Grantor’s entire right, title and interest in and to the Trademark Collateral and hereby reassigns, grants and conveys to Grantor all of Secured Party’s right, title and interest in and to the Trademark Collateral.
2. Secured Party hereby authorizes the Grantor and its successors, assigns or other legal representatives to (i) record this Release with the U.S. Patent and Trademark Office and (ii) otherwise record or file this Release in any applicable governmental office or agency.
3. This Release shall be governed by and construed in accordance with the laws of the State of New York, and shall be binding on the Grantor’s and the Secured Party’s representatives, successors, assigns and transferees.
