**NOTICE OF RELEASE, RELINQUISHMENT & DISCHARGE
OF SECURITY INTEREST**

WHEREAS, Aliments Fontaine Santé Inc., having its principal place of business located at 450 Rue Deslauriers, Saint-Laurent, Québec, Canada H4H 1V8 and Garden Fresh Gourmet, LLC, having its principal place of business located at 450 Rue Deslauriers, Saint-Laurent, Québec, Canada H4H 1V8 (the "**Grantors**") are the owners of the Canadian trademarks listed in Schedule "A" hereto (collectively, the "**Canadian Trademarks**") and the US trademarks listed in Schedule "B" hereto (the "**US Trademarks**") (collectively, the US Trademarks and Canadian Trademarks are referred to as the "**Trademarks**");

WHEREAS, Fédération des caisses Desjardins du Québec, having an office located at 1 Complexe Desjardins, 15th Floor – South Tower, Montréal, Québec, Canada H5B 1B3, as administrative agent and collateral agent for certain lenders ("**Agent**"), entered into a Deed of Hypothec dated as of April 16, 2019, the third amended and restated credit agreement dated as of April 24, 2019, a Pledge and Security Agreement dated as of April 24, 2019, a supplement to the Pledge and Security Agreement dated as of April 26, 2019 (collectively, the "**Security Agreements**"), whereby the Grantors granted to Agent a secured interest in certain property, including the Trademarks, all in consideration of the provision of certain credit facilities to Grantor;

WHEREAS, the Grantors entered into Confirmatory Trademark Security Agreements on April 24 and 26, 2019 (the "**Trademark Security Agreements**") by which each Grantor confirmed that it granted to the Agent a security interest in and to the Trademarks;

WHEREAS, the Trademark Security Agreements were recorded with the Canadian Intellectual Property Office ("**CIPO**") and the U.S. Patent and Trademark Office ("**USPTO**");

WHEREAS, Agent has agreed to release Grantors from the Security Agreements and Trademarks Security Agreements and all underlying and related security interest obligations and to discharge the Security Agreements and Trademark Security Agreements granted by Grantors for such obligations including with respect to the Trademarks.

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by Agent, Agent agrees as follows:

1. Agent, on behalf of itself and the lenders, hereby unconditionally and expressly releases, terminates and discharges all right, title and interest in and to the Trademarks, including all security interest, lien and other encumbrance granted to it in the Trademarks including, without imitation, under the Security Agreements and the Trademark Security Agreements and hereby transfers and assigns to the applicable Grantor any right, title or interest of any kind or nature it may have in, to or under the Trademarks, without representation or warranty;
2. Agent hereby directs the CIPO, the USPTO and any other applicable intellectual property to record the present Notice of Release, Relinquishment & Discharge of Security Interest (the "**Release**") against the Trademarks and in such places as it deems necessary or advisable to give effect hereto.


3. The Agent shall, at the reasonable request and cost of the Grantors, take all further actions, and provide to the Grantors, their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors to more fully and effectively release, terminate, discharge and extinguish any such liens and security interests upon such Trademarks;
4. This Release shall be binding upon the Agent's legal representatives, assigns and successors;
