## Form of Confirmatory Assignment Agreement

**THIS CONFIRMATORY ASSIGNMENT** is made on 17 November 2021

### **BETWEEN**

- (1) Concordia Pharmaceuticals Inc., whose address is 8-10 Avenue de la Gare, L-1610 Luxembourg, Grand-Duchy of Luxembourg, and is registered with the Registre de commerce et des sociétés, Luxembourg (register of trade and companies), by way of its Barbados branch, carrying on business at 5 Canewood Business Centre, St. Michael, Barbados, BB 11005 (the **Assignor**); and
- (2) Mercury Pharma Group Limited, whose address is Capital House, 85 King William St, London EC4N 7BL, United Kingdom, with company number 02330913 (the **Assignee**).

### **BACKGROUND**

- (A) Pursuant to an agreement dated March 1, 2020 between the Parties (the **Agreement**), the Assignor agreed to assign the Trade Marks set out at Schedule A (the **Trade Marks**) to the Assignee with effect from March 1, 2020 (the **Effective Date**).
- (B) The Trade Marks in Schedule A are trade marks or applications for registration used in connection with the Products set out at Schedule B (the **Products**) and, therefore, have been assigned from the Assignor to the Assignee.
- (C) The Parties wish to confirm the assignment of the Trade Marks from the Assignor to the Assignee and the Parties wish to execute this Confirmatory Assignment for the purposes of recordal of that assignment at the applicable intellectual property offices.

### **IT IS AGREED:**

#### **ASSIGNMENT**

For the consideration set out in the Agreement and with effect from the Effective Date, the Assignor hereby assigns to the Assignee (and confirms all previous assignments to the Assignee in respect of the Trade Marks) all its right, title and interest in and to the Trade Marks including:

- (a) all statutory and common law rights attaching to the Trade Marks, together with the goodwill relating to the goods or services in respect of which the Trade Marks are registered or used; and
- (b) the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement or any other

cause of action (including passing off or equivalent or similar claim) arising from ownership of the Trade Marks whether occurring before, on or after the Effective Date.

**FURTHER ASSURANCES**

The Assignee shall prepare all documents necessary for recordal of this Confirmatory Assignment at the relevant intellectual property registries. The Assignor will provide any further assistance and prepare and deliver all documents and do all acts reasonably requested by the Assignee in order to carry out the recordal.


