**TERMINATION AND RELEASE OF  
INTELLECTUAL PROPERTY SECURITY AGREEMENTS**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENTS** (this "*Termination and Release*") is granted as of November 17, 2021 by **SILICON VALLEY BANK**, as Administrative Agent, a California corporation, with a loan production office located at 2400 Hanover Street, Palo Alto, CA 94304 (the "**Bank**"), in favor of **Cambium (US), L.L.C.** (the "**Grantor**").

**WHEREAS**, the Grantor executed and delivered an Intellectual Property Security Agreement, dated as of October 28, 2011 (the "**2011 Agreement**") pursuant to the Credit Agreement and the Guarantee and Collateral Agreement (each as defined in the 2011 Agreement, and collectively all such agreements, the "**Agreements**"), granting to the Bank a security interest in all of its right, title and interest, whether presently existing or hereafter acquired, in, to and under its intellectual property collateral (the "**Intellectual Property Collateral**"), including for the avoidance of doubt, the Patents (as defined in the 2011 Agreement), notice of which was recorded with the United States Patent and Trademark Office ("**USPTO**") on October 28, 2011, at Reel 027144, Frame 0521 and on November 28, 2011, at Reel 027196, Frame 0264, and the Trademarks (as defined in the 2011 Agreement), notice of which was recorded with the USPTO on October 28, 2011, at Reel 4651, Frame 0274 and on November 8, 2011, at Reel 4657, Frame 0381.

**WHEREAS**, Grantor has requested that Bank hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Patents and Trademarks as herein provided; and

**WHEREAS**, Grantor has requested that the Bank provide a document suitable for recording with the USPTO to evidence the release of the Bank's security interests in and liens on the Patents and Trademarks as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby:

1. terminates the Agreements and releases, terminates and discharges fully all liens and security interests thereunder in Grantor's right, title and interest in, to and under the Intellectual Property Collateral, including, without limitation, those patents and patent applications identified in Schedule I hereto and those trademarks and trademark applications identified in Schedule II hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.

THIS TERMINATION AND RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
