TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Termination"), dated as of November 18, 2021, is made by **AB PRIVATE CREDIT INVESTORS LLC**, a Delaware limited liability company, in its capacity as administrative agent (in such capacity, together with any successors and assigns in such capacity, the "Administrative Agent"), in favor of Lexipol, LLC, a Delaware limited liability company and The Praetorian Group, a California corporation (the "Grantors").

WHEREAS, the Grantors, Administrative Agent and the other parties thereto entered into that certain Credit Agreement, dated as of October 8, 2020 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement");

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement dated as of October 8, 2020 (as amended, restated, supplemented, or modified from time to time, the "Trademark Security Agreement"; capitalized terms used herein without definition shall have the meanings ascribed thereto in the Trademark Security Agreement or Credit Agreement, as applicable), by and among Administrative Agent and the Grantors, each Grantor has pledged and granted to Administrative Agent for the benefit of the Secured Parties a security interest in, lien on, and right of set-off against all respective Trademarks of such Grantor, whether then owned or existing or thereafter acquired or arising, in each case excluding any Trademarks that constitute Excluded Property (collectively, the "Trademark Collateral"): (a) all Trademarks of such Grantor, including, without limitation, the United States registered Trademarks and applications for Trademark registration, listed on Schedule A attached hereto; (b) all Goodwill associated with such Trademarks; and (c) all Proceeds of any and all of the foregoing (such lien and security interest, the "Security Interest");

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office on October 8, 2020 at Reel 7073, Frame 0123; and

WHEREAS, Administrative Agent has agreed to terminate and release its Security Interest in each Grantor's entire right, title and interest in, to and under its owned or thereafter acquired Trademark Collateral, including those identified on Schedule A attached hereto.

NOW, THEREFORE, for valuable consideration, Administrative Agent hereby terminates, discharges, cancels and fully and unconditionally releases the collateral pledge, grant, mortgages, liens, collateral assignments, and Security Interest granted to Administrative Agent in the Trademark Collateral and hereby terminates the Trademark Security Agreement.

Administrative Agent hereby reassigns, grants and conveys to each Grantor, without any representation, recourse or undertaking by Administrative Agent, any and all of Administrative Agent's right, title and interest in, to and under the Trademark Collateral.

Administrative Agent authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.


Administrative Agent agrees to take all further actions, and provide to each Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by each Grantor, at each Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Termination.
