**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of November 19, 2021, by **FMP AGENCY SERVICES, LLC**, as collateral agent (in such capacity, “Agent”), in favor of **TSC APPAREL, LLC**, an Ohio limited liability company, and **OURAY SPORTSWEAR, LLC**, a Colorado limited liability company (together, the “Grantors”).

W I T N E S S E T H:

WHEREAS, the Grantors and Agent entered into that certain Second Lien Trademark Security Agreement, dated as of August 21, 2019, notice of which was recorded on August 21, 2019, at the United States Patent and Trademark Office at Reel 6726, Frame 0105 (the “Trademark Security Agreement”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, the Grantors granted Agent, under the terms of the Trademark Security Agreement, a security interest in favor of Agent, in all right, title and interest in, to and under the Trademark Collateral, including without limitation the Trademarks listed in **Schedule A**.

WHEREAS, Agent has agreed to terminate and release its security interest in all Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt of which is hereby acknowledged, and intending to be legally bound, Agent hereby releases, terminates and discharges, and assigns, transfers and conveys to the Grantors, any and all of its security interest in the Trademark Collateral of the Grantors, including the goodwill of the business symbolized thereby.
