**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of November 19, 2021 (“Release”), is made by Truist Bank (as successor by merger to Branch Banking and Trust Company) (“Secured Party”) in favor of ECMD, Inc., a North Carolina corporation (“Debtor”).

WHEREAS, pursuant to that certain Security Agreement dated as of March 2, 2018 (as amended, modified, supplemented and restated from time to time, the “Security Agreement”) by and among the Debtor and Secured Party, Debtor granted to the Secured Party a security interest in the trademark registrations and trademark applications listed on Schedule A attached hereto (collectively, “Trademark Collateral”); and

WHEREAS, pursuant to the Security Agreement, Debtor executed and delivered to Secured Party the Notice of Grant of Security Interest in Trademarks recorded at the United States Patent and Trademark Office (“USPTO”) on March 29, 2018 at Reel 6303 Frame 0308 (“Notice”).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party and Debtor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notice.

SECTION 2. Termination and Release. Secured Party, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the Trademark Collateral, granted pursuant to the Security Agreement or Notice; and


(b) authorizes the recordation of this Release with the USPTO at Debtor’s expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of North Carolina.
