**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of November 19, 2021, by **BANK OF AMERICA, N.A.**, as administrative agent (in such capacity, “Agent”), in favor of **RECOLLECT THREADS LTD.**, a Colorado limited liability company (the “Grantor”).

W I T N E S S E T H:

WHEREAS, the Grantor and Agent entered into that certain Trademark Security Agreement, dated as of January 4, 2021, notice of which was recorded on January 5, 2021, at the United States Patent and Trademark Office at Reel 7155, Frame 0400 (the “Trademark Security Agreement”). WHEREAS, the Grantor granted Agent, under the terms of the Trademark Security Agreement, a security interest in favor of Agent, in all right, title and interest in, to and under the Trademark Collateral, including without limitation the Trademarks listed in **Schedule A**.

WHEREAS, Agent has agreed to terminate and release its security interest in all Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt of which is hereby acknowledged, and intending to be legally bound, Agent hereby releases, terminates and discharges, and assigns, transfers and conveys to the Grantor, any and all of its security interest in the Trademark Collateral of the Grantor, including the goodwill of the business symbolized thereby.
