RELEASE OF SECURITY INTEREST

This Release of Security Interest is made as of November 11, 2021, by COMERICA BANK, a Texas banking association ("Bank") in favor of AMERICAN HEALTH STAFFING GROUP, INC., a Delaware corporation ("AHSG") and AMERICAN HEALTHCARE STAFFING ASSOCIATION, LLC, a Michigan limited liability company ("AHSA"); together with AHSG, each a "Grantor" and collectively, "Grantors") with its principal place of business located at c/o AHS Staffing, LLC, 3051 Willowood Rd, Edmond, OK 73034.

Recital

WHEREAS Grantors granted to Bank a security interest in the trademarks described on Exhibit A, attached hereto (the "Intellectual Property Collateral") under an Intellectual Property Security Agreement dated as of January 31, 2017, by and between Grantors and Bank (the "Security Agreement") and recorded with the US Patent and Trademark Office as set forth on Exhibit A. Bank's security interest recorded at the US Patent and Trademark Office on September 2, 2020, at Reel/Frame Number 7041/0673.

WHEREAS each Grantor has no outstanding obligations to Bank under the terms of the Security Agreement, Bank agrees to release its security interest in the Intellectual Property Collateral.


Agreement
