RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this “Release”), effective as of November 19, 2021, is made by **WILMINGTON TRUST, NATIONAL ASSOCIATION**, in its capacity as Collateral Agent (“Collateral Agent”), in favor of the Grantors (as defined below) and is as follows:

WHEREAS, pursuant to (a) that Credit Agreement, dated as of June 18, 2019 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”) among OVG Holdings, LLC, as Holdings (“Holdings”), OAK VIEW GROUP, LLC, a Delaware limited liability company (“Oak View”), as Borrower, the Lenders from time to time party thereto, XXIII Capital F Limited, as Administrative Agent (in such capacity and together with successors and permitted assigns, the “Administrative Agent”) and the Collateral Agent, and (b) the Pledge and Security Agreement, dated as of June 18, 2019 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Pledge and Security Agreement”), among Holdings, the Borrower, the other grantors from time to time party thereto and the Collateral Agent, the Grantors granted to the Collateral Agent a security interest in and to certain collateral, including trademarks and trademark applications;

WHEREAS, Oak View, **OVG MEDIA & CONFERENCES, LLC**, a Delaware limited liability company (“OVG Media”; and together with Oak View, collectively, the “Grantors”) and Collateral Agent are parties to that certain Trademark Security Agreement, dated as of June 18, 2019 (the “Agreement”), which was recorded with The United States Patent and Trademark Office on June 18, 2019, in its records at Reel 6672, Frame 0561; capitalized terms used but not defined herein will have the meaning given to them in the Agreement;


WHEREAS, reference is hereby made to that certain payoff letter dated as of November 19, 2021, among **OVG HOLDINGS, LLC**, a Delaware limited liability company, Oak View, the Guarantors party thereto, **FORTRESS CREDIT CORP.** (as assignee of XXIII CAPITAL F LIMITED), as Administrative Agent and the Collateral Agent (the “Payoff Letter”).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, subject to and pursuant to the terms of the Payoff Letter, Collateral Agent hereby terminates, discharges, cancels and releases all of its liens and security interests in the Trademark Collateral, including the trademarks listed on Schedule I attached hereto and made a part hereof, which liens and security interests were established under and granted pursuant to the Agreement, and hereby terminates the Agreement, in each case, without recourse, representation or warranty of any kind.
