## TRADEMARK ASSIGNMENT

This Trademark Assignment (this "Assignment"), dated October 13, 2021, is made and entered into by and between SENNHEISER ELECTRONIC CORPORATION, a Delaware corporation ("Assignor"), and SENNHEISER ELECTRONIC GMBH & CO. KG, a German Corporation, having an address of Am Labor 1, 30900 Wedemark, Germany ("Assignee").

WHEREAS, Assignor is an affiliate company of Assignee; and

WHEREAS, Assignee is the sole and exclusive owner of the trademarks of the Sennheiser group worldwide; and

WHEREAS, Assignee is owner of the trademarks **NoiseGard** outside of the US; and

WHEREAS, the registration of the trademarks listed on Schedule A (the "Trademarks") on Assignor was made in error in the name of Assignee; and

WHEREAS, Assignor is the sole and exclusive owner of the entire right, title and interest in and to the trademarks listed on Schedule A (the "Trademarks"), and the goodwill associated therewith; and

WHEREAS, in order to correct the error, Assignor wishes to assign to Assignee all right, title and interest in and to the Trademarks, together with the goodwill associated therewith, nunc pro tunc, effective as of the date of the application, that is for US Reg. No. 2142523 the 19 February 1997, and for US Reg. No. 2092701 the 14 March 1996.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

Assignor does hereby sell, assign, transfer and set over to Assignee the Assignor's entire right, title and interest in and to the Trademarks together with the Assignor's goodwill in connection with which the Trademarks are used, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignor if this Assignment had not been made, together with all income, royalties or payments in respect of the Trademarks due or payable as of the date hereof or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Trademarks, with the right to sue for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives. The assignment of the Trademarks accompanies the transfer of Assignor's business, or portion of the business to which the Trademarks pertains, as required by Section 10 of the Trademark Act, 15 U.S.C. §1060, and that said business is ongoing and existing.






