RELEASE OF TRADEMARK SECURITY INTEREST

WHEREAS, NewPoint Homes, LLC, a Delaware limited liability company with its principal place of business at 3003 East Third Avenue, Suite 201, Denver, Colorado 80206 (the “*Grantor*”), is the owner of record for the trademarks listed on the attached **Schedule A**, registered in the United States Patent and Trademark Office (the “*Trademarks*”).

WHEREAS, the Grantor entered into that certain Trademark Security Agreement dated as of November 20, 2015 (the “*Security Agreement*”), between the Grantor and The Brand Banking Company, a Georgia banking company (“*Brand*”), a true and correct copy of which was recorded with the United States Patent and Trademark Office on December 16, 2015, at Reel/Frame 005690/0810;

WHEREAS, on September 1, 2018, Brand merged into Renasant Bank, a Mississippi banking corporation (“*Secured Party*”), whereby Secured Party became the holder of security interest in the Trademarks;

WHEREAS, a true and correct copy of the Articles of Merger of Brand into Secured Party was recorded with the United States Patent and Trademark office on October 29, 2021, at Reel/Frame 7477/0437;

WHEREAS, the Secured Party desires to release its security interest in the trademarks listed on the **Schedule A** and terminate the Security Agreement;


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby:
