## ASSIGNMENT

CounterPath does hereby transfer, convey, assign, and deliver to Alianza, free and clear of all encumbrances, all right, title, and interest in, to, and under the Trademarks, as well as any registered or common law trademarks or trademark applications for registrations owned by, licensable by, or assignable by CounterPath, which are not listed in Exhibit A, together with the goodwill of the business associated therewith and which is symbolized thereby, all rights to sue for infringement of the Trademarks, whether arising prior to or subsequent to the date of this Assignment, and any and all renewals and extensions thereof that may hereafter be secured under the laws now or hereafter in effect in the United States and in any other jurisdiction, the same to be held and enjoyed by Alianza, its successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by Counterpath had this Assignment not been made. CounterPath acknowledges its obligation to sell, assign, and transfer the rights under the Assignment to Alianza and is unaware of any reason why it may not have the full and unencumbered right to sell, assign, and transfer the rights hereby sold, assigned, and transferred, and has not executed, and will not execute, any document or instrument in conflict herewith.

The Assignment is governed by the substantive laws of the State of Utah and any disputes will be resolved in a Utah state court or federal court sited in Utah.



