**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

This Termination and Release of Trademark Security Agreement (“Trademark Release”) is made as of October 18, 2021, by **WILMINGTON TRUST, NATIONAL ASSOCIATION**, as collateral agent (in such capacity, the “Collateral Agent”) in favor of **VIVID SEATS LLC**, a Delaware limited liability company with an address at 111 North Canal Street, Suite 800, Chicago, IL 60606, **ACTIVE TICKET COMPANY LP**, a Delaware limited partnership with an address at 111 North Canal Street, Suite 800, Chicago, IL 60606, and **WORLD TICKET SOURCE, LLC**, a Delaware limited liability company with an address at 111 North Canal Street, Suite 800, Chicago, IL 60606 (each, a “Grantor” and collectively, the “Grantors”).

WITNESSETH:

WHEREAS, the Grantors entered into a certain trademark security agreement dated May 22, 2020 (the “Trademark Security Agreement”) with Collateral Agent, notice of which was recorded on May 22, 2020 at the United States Patent and Trademark Office at Reel 6945, Frame 0935.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, each Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a security interest (the “Security Interest”) in favor of the Collateral Agent, in and to each such Grantor’s right, title and interest in, to and under all the Trademark Collateral, including without limitation the Trademarks listed in **Schedule A**, and all Goodwill associated with such Trademarks.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantors, including all Goodwill associated therewith, and assigns, transfers and conveys to Grantors the Security Interest in such Trademark Collateral.
