**NOTICE OF RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

November 22, 2021

WHEREAS, Administrative Agent wishes to provide a document suitable for recording in the United States Patent and Trademark Office to evidence the release, relinquishment and discharge of its liens on and security interest in the Trademarks.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, Administrative Agent, as administrative agent for the Secured Parties, hereby, without any representation and warranty and without any recourse to Administrative Agent, terminates, cancels, reassigns, relinquishes, releases and discharges all liens and security interests it has in the Trademarks.
