**NOTICE OF RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

(iii) that certain Trademark Security Agreement, dated as of November 18, 2019, by Grantor, in favor of Administrative Agent for the benefit of certain Secured Parties (as defined therein), and recorded in the United States Patent and Trademark Office at Reel/Frame No. 6799/648, and

(iv) that certain Trademark Security Agreement, dated October 4, 2021, by Grantor, in favor of Administrative Agent for the benefit of certain Secured Parties (as defined therein), and recorded in the United States Patent and Trademark Office at Reel/Frame No. 7449/198,

Grantor conveyed and granted to Administrative Agent, for the benefit of the Secured Parties, a security interest in and to the entire right, title and interest of Grantor in and to the registered trademarks and pending applications shown in the attached Schedules A-1, A-2, A-3, and A-4, respectively (collectively, the “Trademarks”), including, without limitation, all renewals thereof, all proceeds of infringement suits, the rights to sue for past, present and future infringements and all rights corresponding thereto and the goodwill of the business to which each of the Trademarks relates; and

WHEREAS, Administrative Agent wishes to provide a document suitable for recording in the United States Patent and Trademark Office to evidence the release, relinquishment and discharge of its liens on and security interest in the Trademarks.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, Administrative Agent, as administrative agent for the Secured Parties, hereby, without any representation and warranty and without any recourse to Administrative Agent, terminates, cancels, reassigns, relinquishes, releases and discharges all liens and security interests it has in the Trademarks.
