RELEASE OF SECURITY INTEREST IN INTELLECUAL PROPERTY

This Release of Security Interest in Intellectual Property is made as of November 22, 2021, by CRG SERVICING LLC, a Delaware limited liability company, as administrative agent and collateral agent (in such capacities, together with its successors and assigns, "*Administrative Agent*") in favor of FPMCM, LLC, a Delaware limited liability company ("*Grantor*"), with its principal place of business located at 1351 Tie Camp Road, Waynesboro, TN 38485.

Recital

WHEREAS, Grantor granted to Administrative Agent a security interest in substantially all of its personal property, including, but not limited to, the trademarks and trademark applications described on Exhibit A hereof (the "*Intellectual Property*") under that certain Security Agreement, dated as of May 30, 2018 (as amended, restated, amended and restated, supplemented, and/or otherwise modified from time to time, the "*Security Agreement*");

WHEREAS, Administrative Agent perfected its security interest over the Intellectual Property by recording (i) a Trademark Security Agreement, dated as of July 3, 2018 (the "*2018 Trademark Security Agreement*"), and (ii) a Trademark Security Agreement, dated as of May 31, 2019 (together with the 2018 Trademark Security Agreement, collectively, the "*Trademark Security Agreements*"), with the United States Patent and Trademark Office as set forth on Exhibit A;

WHEREAS, Grantor has requested, and Administrative Agent has agreed, to release its security interest in the Intellectual Property and terminate the Trademark Security Agreements.

Agreement

Now, therefore, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, on behalf of itself, the Lenders and their successors, legal representatives and assigns, hereby unconditionally, irrevocably and absolutely agrees that it terminates and releases its security interest in the Intellectual Property, terminates the Trademark Security Agreements, and reassigns to Grantor, without warranty or recourse, all interest of Administrative Agent in the Intellectual Property.

The Administrative Agent shall take all further reasonable actions, and provide to Grantor or its successors, assigns or other legal representatives, all such reasonable cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor to more fully and effectively effectuate the purposes of this Release, in each case, at Grantor's expense. By this instrument, the Administrative Agent authorizes and requests Grantor to record this Release with the USPTO.
