**RELEASE OF TRADEMARK SECURITY AGREEMENT**

THIS RELEASE dated as of September 30, 2013 (this "Release") is made by Laminar Direct Capital L.P., acting in its capacity as administrative agent (in such capacity, the "Administrative Agent") under that certain Trademark Security Agreement, dated as of July 18, 2007 (as amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement") by and among Lucas Associates, Inc., a Georgia corporation, LAI Holdings II, Inc., a Delaware Corporation, LAI Holdings I, Inc., a Delaware corporation, and each of the other grantors named therein (collectively, the "Grantors") and the Administrative Agent.

WHEREAS, pursuant to the Trademark Security Agreement, which was recorded in the records of the United States Patent and Trademark Office on July 23, 2007 at reel 003588, frame 0186, the Grantors granted to the Administrative Agent a continuing security interest in all of Grantors' right, title and interest in, to and under its owned or thereafter acquired trademarks, including those set forth on the attached schedule (the "Trademark Collateral");

WHEREAS, the Grantors has requested and the Administrative Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the "Released Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Administrative Agent in the Released Collateral.
