**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (this "Trademark Release") is made as of November 15, 2021, by **CRYSTAL FINANCIAL LLC (d/b/a SLR Credit Solutions)**, a Delaware limited liability company, as administrative agent and collateral agent for itself and certain other credit parties (in such capacity, the "Grantee") in favor of **THE CHILDREN'S PLACE SERVICES COMPANY, LLC**, a Delaware limited liability company ("TCP"), **TCP BRANDS, LLC**, a Delaware limited liability company ("TCP BRANDS"), and **THE CHILDREN'S PLACE (CANADA), LP**, an Ontario limited partnership, by its general partner, **TCP INVESTMENT CANADA II CORP.** ("TCP CANADA"), and together with **TCP** and **TCP BRANDS**, each a "Grantor" and, collectively, the "Grantors").

WHEREAS, pursuant to that certain Grant of Security Interest in Trademarks, dated as of October 5, 2020, by and among the Grantors and the Grantee (as amended, amended and restated, restated, supplemented, modified or otherwise in effect prior to the date thereof, the "Trademark Grant"), the Grantors unconditionally granted, assigned, and pledged to the Grantee a continuing security interest (the "Security Interest") in (i) all of each Grantor's right, title and interest in, to and under the trademarks owned by it, including without limitation those trademarks set forth on Schedule I attached hereto (the foregoing, collectively the "Marks"), (ii) all proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated, and (iv) all causes of action arising prior to or after October 5, 2020 for infringement of any of the Marks or unfair competition regarding the same (the foregoing (i) through (iv), collectively, the "Trademark Collateral");

WHEREAS, the Trademark Grant was recorded with the United States Patent and Trademark Office (the "USPTO") on October 8, 2020 at Reel 007068, Frame 0734; and

WHEREAS, the Grantors have requested that the Grantee execute this Trademark Release in order to terminate and release the Grantee's Security Interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged:

1. Defined Terms. Capitalized terms used herein without definition are used as defined in the Trademark Grant.
2. Release of Lien. The Grantee hereby terminates the Trademark Grant and hereby, without any representation or warranty, (i) terminates, cancels and releases its Security Interest and all other liens and security interests that it has in, to and under the Trademark Collateral and (ii) reassigns, grants and conveys to each Grantor any and all right, title and interest it has in the Trademark Collateral, in each case, including, without limitation, those Marks referred to on Schedule I attached hereto and all the goodwill of the businesses with which the Marks are associated.
3. Authorization to Record. The Grantee authorizes and requests that this Trademark Release be filed with the USPTO and any applicable government officer record this Trademark Release.
4. Governing Law. This Trademark Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted with, the laws of the State of New York.




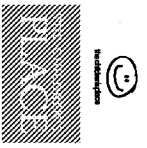
