**TERMINATION AND RELEASE OF
SECOND LIEN SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Second Lien Security Interest in Trademarks (“Trademark Release”) is made as of November 1, 2021, by **UBS AG, STAMFORD BRANCH**, as collateral agent for certain secured parties (“Collateral Agent”) in favor of **C & A INDUSTRIES, LLC**, a Nebraska limited liability company with an address at 13609 California Street, Suite 500, Omaha, Nebraska 68154 (the “Grantor”).

W I T N E S S E T H:

WHEREAS, the Grantor entered into a certain trademark security agreement dated October 7, 2019 (the “Trademark Security Agreement”) with Collateral Agent, notice of which was recorded on October 7, 2019 at the United States Patent and Trademark Office at Reel 6765, Frame 0143.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to all of its Trademark Collateral (as defined in the Trademark Security Agreement), including without limitation the Trademarks listed in **Schedule A**.


WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantor, and assigns, transfers and conveys to Grantor such Security Interest.


