**TERMINATION AND RELEASE OF  
FIRST LIEN SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of First Lien Security Interest in Trademarks (“Trademark Release”) is made as of November 1, 2021, by **UBS AG, STAMFORD BRANCH**, as collateral agent for certain secured parties (“Collateral Agent”) in favor of **PROFESSIONAL PLACEMENT RESOURCES, LLC** a Florida limited liability company with an address at 333 First Street North, Suite 200, Jacksonville Beach, Florida 32250, and **360 HEALTHCARE STAFFING LLC**, a Delaware limited liability company with an address at 333 First Street North, Suite 200, Jacksonville Beach, Florida 32250 (each, a “Grantor” and collectively, the “Grantors”).

W I T N E S S E T H:

WHEREAS, the Grantors entered into a certain trademark security agreement dated March 1, 2018 (the “Trademark Security Agreement”) with Collateral Agent, notice of which was recorded on March 6, 2018 at the United States Patent and Trademark Office at Reel 6301, Frame 0947.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, each Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to all of each such Grantor’s Trademark Collateral (as defined in the Trademark Security Agreement), including without limitation the Trademarks listed in **Schedule A**.


WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantors, and assigns, transfers and conveys to Grantors such Security Interest.


