ASSIGNOR hereby agrees to execute any additional documents to accomplish this Assignment.

Notwithstanding any provision to the contrary set forth herein or in the CDA or in any document, instrument or agreement executed in connection herewith or therewith, no provision of this Assignment in any way waives, restricts, alters, diminishes, or limits the express provisions (including the warranties, covenants, agreements, conditions, representations and obligations and indemnifications, and the limitations related thereto, of the Parties) set forth in the CDA, this Assignment being intended solely to effect the transfer of the Trademarks strictly in accordance with the terms of the CDA. In the event of a conflict between the terms of this Assignment and the terms of the CDA, the terms of the CDA shall prevail and govern.

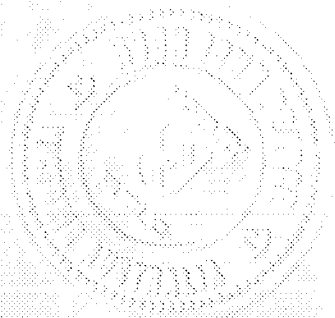

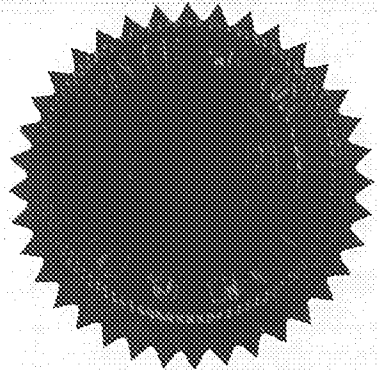
