ASSIGNMENT

THIS ASSIGNMENT (the “**Assignment**”) is made as of June 14, 2021, by and among Centennial Bank, an Arkansas banking corporation (“**Assignor**”) and Island IP Acquisitions, LLC, a Delaware limited liability company (“**Assignee**”). Assignor and Assignee are collectively referred to herein as the “**Parties**” and individually as a “**Party**.”

BACKGROUND

WHEREAS, Assignor and Assignee have entered into a certain Intellectual Property Purchase dated February 1, 2021 (the “**Purchase Agreement**”), pursuant to which Assignor sold and transferred to, and Assignee purchased and acquired from Assignor, its rights in certain intellectual property;

WHEREAS, this Assignment is intended to further evidence various actions contemplated by the Purchase Agreement;

NOW, THEREFORE, in consideration of the premises and mutual covenants, conditions and agreements set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. Defined Terms. Except as specified otherwise, when used in this Agreement and any Exhibits or Schedules, the following terms shall have the meanings specified below:

“**Domain Names**” means the domain names generally described in the Scheduled IP, Domain Names, including without limitation the domain names listed on Annex 1 hereto.

“**Final Judgment**” means that *Summary Final Judgment (Security Interest) as to Island Company, LLC, Spencer Anile and Island Company Lifestyle Products LLC* entered on September 9, 2019 in the case styled *Centennial Bank, vs. Island Company, LLC, et al.* (Case No. 502019CA004196XXXXMB) in the Circuit Court of the 15th Judicial Circuit in and for Palm Beach County, Florida, which foreclosed the defendants’ interest in, among other property, the Intellectual Property Rights and expressly authorizes Seller to sell the Intellectual Property Rights free and clear of all claims of any of the defendants. A copy of the Final Judgment is attached hereto as Exhibit B.

“**Intellectual Property Rights**” means all of the Seller’s right, title and interest in or relating to:

- (i) the intellectual property identified in the attachment specifically referenced in paragraph 3 of the Final Judgment, including without limitation the and Trademarks and the Domain Names (the “**Scheduled IP**”);
- (ii) the various rights and privileges of the Seller under the third and fourth numbered order of the Final Judgment, including various rights of possession and rights to convey the Scheduled IP; and
- (iii) the right to apply for registrations, certificates or renewals with respect any of the foregoing items and the right to prosecute, enforce, obtain damages relating to, settle or release any past, present or future infringements thereof.

“**Person**” means any natural person, general or limited partnership, company, corporation, association, limited liability company or other entity.

“**Purchased Intellectual Property**” means the Intellectual Property Rights.

“**Recordations**” means documents filed or to be filed with the United States Patent and Trademark Office and other trademark offices and domain name registrars throughout the world for the purpose of recording notice of, confirming, and giving effect to the assignment of the Purchased Intellectual Property by the Seller to the Buyer.

“**Trademarks**” means the trademarks generally described in the Scheduled IP, which is understood to include the trademarks listed in Annex B hereto.

2. Assignment of Trademarks and Domain Names. Effective as of the date hereof, Assignor hereby assigns, transfers and conveys to Assignee all of Assignor’s right, title and interest in and to the Trademarks and the Domain Names, together with the goodwill of the business appurtenant thereto and symbolized thereby, throughout the world to be held and enjoyed by Assignee, for its own use, and for its legal representatives and assigns, as fully and entirely as the same would have been held by Assignor had this assignment not been made. Without limiting the forgoing, Assignor hereby assigns, transfers and conveys to Assignee (i) all common law trademarks for which no applications or registrations exist, all applications to register any of the assigned Trademarks, and all registrations that have been or may be granted for any of the assigned Trademarks, together with all common law rights associated with the applications and registrations, , and (ii) the right to sue for damages and other remedies for any past, present and future infringements or violations thereof and rights of priority and protection of interests therein under the laws of any jurisdiction worldwide.
3. Assignment of Purchased Intellectual Property. Effective as of the date hereof, Assignor hereby assigns, transfers and conveys to Assignee all of Assignor’s right, title and interest in and to the Purchased Intellectual Property, including, without limitation, the right to sue for damages and other remedies for any past, present and future infringements or violations thereof and rights of priority and protection of interests therein under the laws of any jurisdiction worldwide.
4. Further Assurances. Assignor agrees, without further consideration, to take all such other action and to procure or execute, acknowledge, and deliver all such further certificates, conveyance instruments, consents, and other documents as Assignee may reasonably request to vest in Assignee, and perfect and protect Assignee’s right, title, and interest in, and enjoyment of the Purchased Intellectual Property, including without limitation the Trademarks, and the Domain Names .
5. Successors and Assigns. This Assignment shall be binding upon and shall inure to the benefit of and shall be enforceable by Assignor, Assignee and their respective heirs, legal representatives, successors and assigns.

6. Governing Law and Jurisdiction. This Assignment shall be construed and interpreted according to the laws of the State of Florida, without regard to the conflict of law principles thereof. The Parties agree that the exclusive venue and jurisdiction for any actions or disputes arising from this Assignment shall be a federal or state court in Florida.
7. Severability. If any provision, clause or part of this Assignment or the application thereof under certain circumstances is held invalid or unenforceable, the remainder of this Assignment, or the application of such provision, clause or part under other circumstances, shall not be affected thereby.
8. Counterparts. This Assignment may be executed simultaneously in two or more counterparts, each of which shall be deemed an original and all of which taken together shall constitute one and the same document. Execution and delivery of this Assignment by exchange of facsimile copies bearing the facsimile signature of a Party hereto shall constitute a valid and binding execution and delivery of this Assignment by such Party. Such facsimile copies shall constitute enforceable original documents.
9. Waiver and Amendments. No failure or delay on the part of either Party in exercising any of its respective rights hereunder upon any failure by the other Party to perform or observe any condition, covenant or provision herein contained shall operate as a waiver thereof, nor shall any single or partial exercise of any such rights preclude any other or further exercise thereof or the exercise of any other right hereunder. This Assignment may not be amended, modified or waived except by written agreement signed by Assignor and Assignee.
10. Entire Agreement. This Assignment and the Schedules attached hereto constitute the entire agreement between the Parties relating to the subject matter hereof and supersede all prior and contemporaneous agreements, understandings, negotiations and discussions of the Parties, whether oral or written. The Schedules attached hereto are incorporated herein by this reference and are hereby made part of this Assignment.

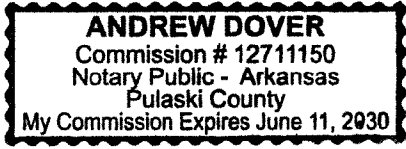
