TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement is effective as the 29th day of October, 2021 between Zzzzing Productions LLC, a limited liability company organized and existing under the laws of the State of Nevada ("Assignor") and Elissa Zucker, an individual with citizenship and residence in the United States ("Assignee") (collectively, the "Parties").

WHEREAS, Assignor is the owner of all right, title, and interest in and to the trademark DOOMSDAY HAPPY HOUR (standard characters) and DOOMSDAY HAPPY HOUR & design (the "Marks");

WHEREAS, Assignee wants to acquire all right, title, and interest in and to said Marks, and the goodwill of the business associated with the use of, and symbolized by, the Marks, and Assignor wants to transfer its rights in said Marks to Assignee;

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Parties agree, as follows:

1. Assignor hereby sells, transfers, and assigns to Assignee all of Assignor's right, title, and interest in the Marks as they exist anywhere in the world, along with the goodwill of the business associated with the use of, and symbolized by, the Marks.
2. This Assignment includes without limitation the transfer of all Assignor's right, title, and interest in the U.S. registration number 6,286,723 issued on March 9, 2021 and in the U.S. registration number 6,292,690 issued on March 16, 2021 of DOOMSDAY HAPPY HOUR & design, both for "*Entertainment and educational services, namely, the provision of continuing shows featuring comedy, commentary, performances, interviews, discussion, and audience participation distributed via various platforms across multiple forms of transmission media; providing a website featuring non-downloadable articles and videos in the fields of comedy, career advice and guidance, current events, politics, history, religion, social issues, culture, pop culture, parenting, child development, and relationships; on-line journals, namely, blogs featuring entertainment and educational information and commentary in the fields of comedy, career advice and guidance, current events, politics, history, religion, social issues, culture, pop culture, parenting, child development, and relationships; entertainment and educational services, namely, providing podcasts and webcasts in the fields of comedy, career advice and guidance, current events, politics, history, religion, social issues, culture, pop culture, parenting, child development, and relationships; online electronic publishing of books and periodicals*" in International Class 41.
3. This Assignment further includes without limitation the exclusive right to enforce and to obtain other registrations for the Marks in the United States and throughout the world in the sole name of the Assignee; all rights to the proceeds of the Marks, including income, royalties, damages, profits, and payments now, retroactively, or hereafter payable; and all rights of action of Assignor, and the right to take proceedings and to seek damages and

all other available remedies, against third parties for past, present, or future infringement of the Marks.

4. Assignor represents and warrants that it is the owner of the Marks, has not sold or transferred either Marks to any third party; that to its knowledge, no third party has taken or used either Marks without authorization; and that it has the authority to enter into this Agreement.
5. Except as expressly provided herein, Assignor makes no representations, warranties, covenants, agreements, or indemnities, and hereby disclaims all implied warranties, with respect to the validity of, or Assignor's or Assignee's ability to use, register, or enforce the Marks.
6. Assignor authorizes the Commissioner for Trademarks of the United States Patent and Trademark Office to record and register this Trademark Assignment upon the request of Assignee. Assignor shall execute and deliver any other documents and perform any other reasonable acts that Assignee may request, in order to vest all of Assignee's right, title, and interest to the Marks and establish Assignee's rights in the Marks.
7. The Parties' rights and obligations stated herein shall be binding upon successors and assigns of the Parties.
8. This Agreement is the entire agreement between the Parties regarding the Marks.
