**TERMINATION AND RELEASE OF SECURITY  
INTEREST IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of November 19, 2021 (this "Release"), is made by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, a national banking association ("Lender"), in favor of **THE STRATIX CORPORATION**, a Georgia corporation ("Grantor").

**WHEREAS**, pursuant to that certain (a) Trademark Security Agreement dated as of March 12, 2020, between Grantor and Lender, and (b) Trademark Security Agreement dated as of February 16, 2016, between Grantor and Lender (each such Trademark Security Agreement referred to in the foregoing clauses (a) and (b), each, a "Security Agreement" and, collectively, the "Security Agreements"), Grantor granted to Lender a continuing security interest in all right, title and interest of Grantor in and to the Trademark Collateral (as defined in each Security Agreement), including the trademarks identified on the attached Schedule A; and

**WHEREAS**, the security interests identified herein were recorded with the United States Patent and Trademark Office ("USPTO") on March 12, 2020, at Reel 6889 Frame 0382, and February 25, 2016, at Reel 5739 Frame 0414.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender and Grantor agree as follows:

**SECTION 1. Defined Terms**. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in each Security Agreement referenced in the preamble and recitals hereto.

**SECTION 2. Termination and Release**. Lender without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

(a) terminates, cancels, discharges and releases the continuing security interest in, Grantor's right, title, and interest in and to the trademarks identified on Schedule A attached hereto, granted pursuant to each Security Agreement; and


(b) authorizes the recordation of this Release with the USPTO at Grantor's expense.

**SECTION 3. Choice of Law**. This Release shall be governed by and construed in accordance with the laws of the State of New York.
