**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this “Release”), dated as of November 30, 2021, is made by BMO HARRIS BANK, N.A., in its capacity as administrative agent (the “Administrative Agent”), in favor of DOMAILLE ENGINEERING, LLC, a Missouri limited liability company (“Domaille Engineering”) and TECH MANUFACTURING, LLC, a Missouri limited liability company (“Tech” and collectively with Domaille Engineering, the “Grantors”). Capitalized Terms used but not defined herein shall have the meanings set forth in the Security Agreement and IP Security Agreements, as applicable.

WITNESSETH:

WHEREAS, pursuant to that certain Security and Pledge Agreement dated as of February 1, 2019 (as reaffirmed, amended, supplemented or otherwise modified from time to time, the “Security Agreement”), among the Grantors and the other parties party thereto executed in favor of the Administrative Agent, and those certain agreements described on Annex I attached hereto (the “IP Security Agreements”), the Grantors granted a continuing security interest (the “Security Interest”) in all of Grantor’s right, title and interest in, to and under certain collateral in favor of the Administrative Agent, including the Patent Collateral, the Trademark Collateral, and the Copyright Collateral, as defined in each of the IP Security Agreements (collectively, the “IP Collateral”), and including the Copyrights, Patents and Trademarks listed on Annex II attached hereto; and


WHEREAS, the Administrative Agent now desires to terminate and release the IP Security Agreements and the entirety of its security interest in the IP Collateral, including the Copyrights, Patents and Trademarks described on Annex II attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Administrative Agent without recourse, representation or warranty and at the Grantors’ sole cost and expense, hereby (i) terminates and cancels the IP Security Agreements, (ii) terminates, cancels, releases, relinquishes and discharges, in its entirety, for the benefit of the Grantors, and their successors and assigns, the Security Interest in the IP Collateral, and (iii) reassigns, transfers, and conveys to each Grantor any right, title or interest, if any, the Administrative Agent may have in the IP Collateral. The Administrative Agent hereby authorizes each Grantor, and any successor to such Grantor (including any person or entity hereafter having any right, title or interest in and to the IP Collateral of such Grantor) to record this Release with the United States Patent and Trademark Office and the United States Copyright Office, at the sole expense of such Grantor, to evidence and effectuate the release and termination of the Security Interest in the IP Collateral.
