**RELEASE OF TRADEMARK SECURITY AGREEMENT**

This **RELEASE OF TRADEMARK SECURITY AGREEMENT** ("**TRADEMARK RELEASE**") is made as of November 24, 2021 ("**Effective Date**") executed by **CAPITAL ONE, NATIONAL ASSOCIATION** (as successor-in-interest to Healthcare Financial Solutions, LLC, the "**Agent**"), in favor of **REVISION, LLC**, a Delaware limited liability company ("**Revision**"), **GOODIER COSMETICS, LLC**, a Delaware limited liability company ("**Goodier**"), **JAMRM, LLC**, a Texas limited liability company ("**JAMRM**") and together with Revision and Goodier, collectively, the "**Grantors**" and each individually, a "**Grantor**").

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated as of August 1, 2016 (the "**Trademark Security Agreement**"; capitalized terms used but not defined herein shall have the meaning ascribed to such terms in the Trademark Security Agreement or the Guaranty and Security Agreement (as defined in the Trademark Security Agreement), as applicable), by the Grantors in favor of the Agent, the Grantors granted to the Agent a continuing Lien on and security interest in and to all of the Grantors' right, title and interest in, to and under (i) the pending and registered trademarks referred to on Schedule I attached hereto (the "**Trademarks**"), (ii) all renewals of the foregoing, (iii) all goodwill of the business connected with the use of, and symbolized by, each such Trademark, and (iv) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof (collectively the "**Trademark Collateral**");

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on August 1, 2016 at Reel 5844 Frame 0552;

**WHEREAS**, the Agent wishes to terminate the Trademark Security Agreement and release and restore all right, title and interest in and to the Trademark Collateral to the Grantors and to dissolve those liens and encumbrances created by the Trademark Security Agreement in respect of the Trademark Collateral as set forth on Schedule I attached hereto.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby (i) terminates the Trademark Security Agreement, (ii) terminates, cancels and releases any and all security interests or Liens it has and all of its right, title and interest in, to and under the Trademark Collateral, whether now owned or hereafter created or acquired by the Grantors, (iii) reassigns, grants and conveys to Grantors, without any representation, recourse or undertaking by the Agent, any and all of the Agent's right, title and interest in and to the Trademarks and Trademark licenses; and (iv) authorizes and requests the Commissioner for Trademarks of the United States of America to note and record the existence of the release hereby given.
