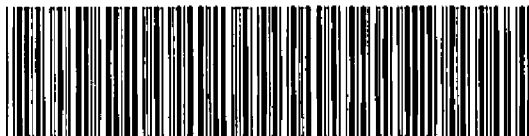

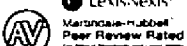

THESE ARTICLES OF CONVERSION are made as of this 13th day of July, 2018, by and between J&K Products, LLC and K&J Products, LLC.

EXPLANATORY STATEMENT

J&K Products, LLC (the "Maryland LLC") was formed as a limited liability company under Maryland law.

The Maryland LLC desires to convert to a Florida limited liability company pursuant to Section 4A-1101(b) of the Maryland Limited Liability Company Act (the "Act").

NOW THEREFORE, the undersigned, being authorized to execute and file these Articles of Conversion, hereby certifies to the Maryland State Department of Assessments and Taxation (SDAT) as follows:

FIRST: The name of the Maryland LLC is "J&K Products, LLC."

SECOND: The Maryland LLC was formed as a Maryland limited liability company on January 28, 2016 by the filing of Articles of Organization with SDAT.

THIRD: The name of the Florida limited liability company into which the Maryland LLC shall convert shall be "K&J Products, LLC" (the "Florida LLC").

FOURTH: The terms and conditions of the conversion were advised, authorized, and approved by the Maryland LLC by the unanimous written consent of its Members as set forth in Subtitle 11 of the Act.

FIFTH: The manner and basis for converting the outstanding Membership Interests in the Maryland LLC into Membership Interests in the Florida LLC are as follows:

Each one percent (1%) Membership Interest in the Maryland LLC as it exists immediately prior to the conversion will become a one percent (1%) Membership Interest in the Florida LLC on the effective date of the conversion.

SIXTH: The conversion will be effective on August 1, 2018, which is a date within thirty (30) days of the filing of these Articles of Conversion with SDAT.

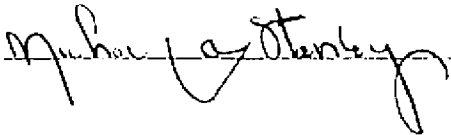
