TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made in favor of ESS Northeast, LLC (f/k/a S4Teachers LLC), a Delaware limited liability company ("Grantor"), by The Prudential Insurance Company of America, in its capacity as collateral agent (in such capacity, the "Collateral Agent"), for the Note Holders (as defined in the Security Agreement dated as of April 14, 2015 made by the Grantor and the other parties party thereto in favor of the Collateral Agent and the Note Holders) (the "Secured Parties").

WHEREAS, pursuant to that certain Assignment of Security Interest in Trademarks, dated as of April 16, 2015, by and among Grantor and the Collateral Agent, for the benefit of itself and the Secured Parties, the Grantor has granted to Collateral Agent a lien on and security interest in all of such Grantor's right, title and interest in and to the trademark applications and trademark registrations set forth on Schedule 1 attached hereto (collectively, the "Trademarks");

WHEREAS, Collateral Agent's lien and security interest in the Trademarks was recorded with the United States Patent and Trademark Office on May 22, 2015 at Reel/Frame 5522/0571;

WHEREAS, the Grantor has paid all of its outstanding indebtedness to the Collateral Agent and the Secured Parties; and


WHEREAS, the Collateral Agent wishes to terminate, cancel and release all liens and security interests it has in and on the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates, cancels and releases all liens and security interests it has in and on the Trademarks; all income, royalties, damages and payments now and hereafter due and/or payable related thereto, including without limitation, damages and payments for past or future infringements thereof; the right to sue for past, present and future infringements thereof; and any goodwill associated thereto.
