## RELEASE OF TRADEMARK SECURITY INTEREST

November 23, 2021

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of August 24, 2020, that was recorded August 26, 2020, at the United States Patent and Trademark Office on Reel: 007033; Frame: 0920 (the "Trademark Security Agreement"), JAPONESQUE, LLC, a California limited liability company ("Grantor"), pledged and granted to GRAYCLIFF MEZZANINE III LP, as Administrative Agent (the "Agent"), a security interest in the Trademark Collateral (as defined in the Trademark Security Agreement) including, without limitation, those trademarks listed on Exhibit A attached hereto; and

WHEREAS, Grantor has requested and the Agent has agreed to provide this Release of Trademark Security Agreement to confirm the release, relinquishment and discharge of its continuing security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement or the Security Agreement referred to therein.

2. Release of Security Interest. The Agent hereby, without any representation and warranty and without any recourse (a) terminates the security interests created under the Trademark Security Agreement in the Trademark Collateral, (b) releases its security interest in the Trademark Collateral, (c) discharges any and all rights, title and interest it has in and the security interest granted to the Agent in the Trademark Collateral, and (d) terminates the Trademark Security Agreement except for any provisions therein that expressly survive termination.

The Agent hereby authorizes Grantor and its agents, representatives, assigns and designees to record this Release of Trademark Security Agreement with the United States Patent and Trademark Office.

IN WITNESS WHEREOF, the Agent has caused this Release of Trademark Security Agreement to be executed by its duly authorized officer as of the date first written above.
