**RELEASE AND TERMINATION  
OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE AND TERMINATION OF SECURITY INTEREST IN TRADEMARKS, dated as of November 30, 2021 (this "Release"), is made by Wells Fargo Bank, National Association, acting in its capacity as administrative agent for the Lender Group and the Bank Product Providers (in such capacity, the "Collateral Agent") under that certain Trademark Security Agreement dated as of April 26, 2021 (as amended, restated, amended and restated, supplemented or otherwise modified and in effect from time to time, the "Trademark Security Agreement"), by and among Boyd Assets Co., a Delaware corporation (the "Assignor"), the other Grantors party thereto and the Collateral Agent. NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent does hereby (a) terminate the security interest created under the Trademark Security Agreement in the Trademark set forth on the attached Schedule A, (b) release and relinquish its security interest in the Trademark set forth on the attached Schedule A, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Collateral Agent in the Trademark set forth on the attached Schedule A. The Collateral Agent agrees, or authorizes the Assignor, to make filings with the United States Patent and Trademark Office and take further actions, as reasonably requested by the Assignor to evidence the release and termination of the Collateral Agent's security interests in the Trademark set forth on the attached Schedule A.
