RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “Release”), dated as of November 30, 2021, is made by GOLUB CAPITAL LLC, as collateral agent for the Secured Parties (in such capacity, the “Collateral Agent”) in favor of VETERINARY SPECIALISTS OF NORTH AMERICA LLC, a Delaware limited liability company, and GREAT VET LLC, a Delaware limited liability company (each a “Grantor”, and collectively, the “Grantors”). Capitalized terms not defined herein shall have the meaning ascribed to them, directly or by reference, in the IP Security Agreement (as defined below).

WHEREAS, the Grantors, the Collateral Agent, and certain other parties entered into that certain Pledge and Security Agreement, dated as of April 1, 2019 (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, pursuant to the Security Agreement, the Grantors executed and delivered that certain Intellectual Property Security Agreement, dated April 1, 2019, in favor of the Collateral Agent (the “IP Security Agreement”), which was recorded in the United States Patent and Trademark Office on April 2, 2019 at Reel/Frame 6606/0120 (with respect to Veterinary Specialists of North America LLC) and at Reel/Frame 6606/0128 (with respect to Great Vet LLC);

WHEREAS, pursuant to the Security Agreement and the IP Security Agreement, each Grantor pledged, assigned and granted to the Collateral Agent, on behalf of and for the ratable benefit of the Secured Parties, a continuing security interest (the “Security Interest”) in all of such Grantor’s right, title and interest in, to and under all Intellectual Property, whether then owned by or owing to, or thereafter acquired by or arising in favor of, such Grantor, including (i) any and all Patents, (ii) any and all Trademarks; (iii) any and all Copyrights; (iv) any and all registrations and applications for registration for any of the foregoing in the USPTO or the Copyright Office, as applicable, including, without limitation, the registrations and applications for registration of U.S. Patents, Trademarks, and Copyrights set forth in Schedule A, together with all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations thereof; and (v) any and all exclusive licenses to one or more Copyrights registered with the Copyright Office (the “IP Collateral”); provided, that the Security Interest does not extend to, and the term “IP Collateral” does not include, any Excluded Assets; and

WHEREAS, the Grantors have requested that the Collateral Agent now fully discharge, terminate and release its Security Interest in the IP Collateral.


NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration the receipt and adequacy of which are hereby acknowledged, the Collateral Agent hereby (i) terminates the IP Security Agreement, (ii) fully discharge, terminates and releases the Security Interest in the IP Collateral, and (iii) re-assigns to each Grantor any right, title or interest it may have in the IP Collateral of such Grantor, in each case without recourse to the Collateral Agent, and without representation or warranty of any kind.

Each Grantor (and any successor to such Grantor, including any person or entity hereafter holding any right, title or interest in and to the IP Collateral of such Grantor) is hereby authorized to record this Release with the United States Patent and Trademark Office or the United States Copyright Office, as applicable. **THIS RELEASE SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK.** Delivery of an executed counterpart of a signature page to this Release by email or other electronic (including in “.pdf” or “.tif” format) means shall be effective as delivery of a manually executed counterpart of this Release.
