CONFIRMATORY RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS CONFIRMATORY RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made effective as of September 30, 2021, by PNC Bank, National Association (the "Agent"), in favor of Yunhong CTI Ltd. (f/k/a CTI Industries Corporation), an Illinois corporation (the "Grantor").

WHEREAS, pursuant to that certain Revolving Credit, Term Loan and Security Agreement dated as of December 14, 2017, by and among the Grantor, certain affiliates of the Grantor from time to time party thereto, as guarantors, the financial institutions from time to time party thereto (the "Lenders"), and the Agent, in its capacity as administrative agent (as amended, restated, supplemented, or otherwise modified from time to time, the "Credit Agreement"), the Agent and Lenders made certain financial accommodations to the Grantor;

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of December 14, 2017 (as amended, supplemented or otherwise modified from time to time, the "Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office at Reel/Frame No. 6228/0404 by and between the Grantor and the Agent, the Grantor granted the Agent a security interest in, among other things, the trademarks, trademark rights, and trademark applications listed on Exhibit A attached hereto (collectively, the "Trademarks"), and pledged (but did not transfer title to) the Trademarks to the Agent;

WHEREAS, as of the effective date hereof, all obligations of the Grantor owing to the Agent under the Credit Agreement have been satisfied, and the Grantor has requested the Agent release its security interest in the Trademarks in accordance with this Release; and

WHEREAS, the Agent, in its capacity as administrative agent, previously executed a Release of Security Interest in Trademarks dated as of September 30, 2021, recorded in the U.S. Patent and Trademark Office on October 1, 2021 at Reel/Frame No. 7441/0067, which released security interests granted in the Trademark Security Agreement and, for the avoidance of doubt, now wishes to execute this Release to confirm that the security interests in all of the Trademark Collateral (as defined in the Trademark Security Agreement) have been released.

NOW, THEREFORE, for valuable consideration:

The Agent hereby confirms that it has terminated and released, and hereby terminates and releases, its security interest in the Trademarks and the Trademark Collateral (as defined in the Trademark Security Agreement, and the Agent hereby confirms that it has assigned and transferred, and hereby assigns and transfers, to the Grantor as identified on Exhibit A, without any representation, warranty, or recourse whatsoever, the Agent's entire right, title, and interest in and to the Trademarks and the Trademark Collateral, effective as of the date set forth above.

The Agent hereby agrees to execute such further instruments and documents and perform such further acts as the Grantor may deem necessary to convey to the Grantor the rights herein conveyed.
