GRANT OF SECURITY INTEREST  
IN UNITED STATES TRADEMARKS

November 30, 2021

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, the undersigned Grantor (the "Grantor"), hereby grants to PNC BANK, NATIONAL ASSOCIATION, as Agent (the "Grantee"), a continuing security interest in all of the Grantor's right, title and interest in, to and under to the trademarks set forth on Schedule A attached hereto (the "Trademarks").

THIS GRANT is made to secure the satisfactory performance and payment of all the Obligations of the Grantor, as such term is defined in the Credit and Security Agreement dated as of November 30, 2021 (the "Credit Agreement") by and among APG Vinyl Intermediate, LLC, a Delaware limited liability company ("APG Vinyl"), Interwest Distribution Company, LLC, a Delaware limited liability company ("Interwest Distribution"), Fellers, LLC, a Delaware limited liability company ("Fellers"), Interwest Tools, LLC, a Colorado limited liability company ("Interwest Tools"), Cheetahwrap, LLC, an Oklahoma limited liability company ("Cheetahwrap"), and together with APG Vinyl, Fellers, Interwest Distribution and Interwest Tools, collectively, the "Borrowers" and each, a "Borrower"), APG Vinyl Holdings, LLC ("Holdings"), the other guarantors party thereto (collectively with Holdings, the "Guarantors"), the financial institutions party thereto as lenders (the "Lenders") and PNC BANK, NATIONAL ASSOCIATION, as agent for the benefit of Lenders (the "Agent"). Upon the occurrence of the termination of the Credit Agreement pursuant to Section 13 thereof this Grant shall automatically and immediately terminate and the Grantee shall execute, acknowledge, and deliver to the Grantor an instrument in writing releasing the security interest in the Trademarks acquired under this Grant.


