**RELEASE OF SECURITY INTEREST IN  
INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (the "Release") is dated as of November 19, 2021 by ZIONS BANCORPORATION, N.A., dba Amegy Bank of Texas, a national banking association (formerly known as ZIONS BANCORPORATION, N.A., dba AMEGY BANK and as ZB N.A., DBA AMEGY BANK) ("Lender") in favor of UATP Management, LLC, a Texas limited liability company ("Borrower"), and UATP IP, LLC, a Texas limited liability company (together with Borrower, the "Grantors").

**WITNESSETH**

WHEREAS, the Borrower and the Lender have entered into that certain Loan Agreement dated as of March 1, 2018 (as amended, restated, supplemented or otherwise modified from time to time, the "Loan Agreement");

WHEREAS, in connection with the Loan Agreement, each Grantor entered into that certain Security Agreement, dated as of March 1, 2018 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), in favor of Lender, pursuant to which each Grantor were required to execute and deliver to the Lender that certain Intellectual Property Security Agreement dated as of March 1, 2018 (the "Intellectual Property Security Agreement") and recorded with the Trademark Division of the United States Patent and Trademark Office ("USPTO") on March 14, 2018 at Reel/Frame 006291/0440, the Patent Division of the USPTO on March 14, 2018 at Reel/Frame 045208/0499, and the United States Copyright Office ("USCO") on March 21, 2018 at Volume/Doc. No. 9955/735, pursuant to which the Grantors granted and pledged to the Lender a security interest in all of their right, title and interest in, to and under the Collateral (as defined in the Intellectual Property Security Agreement);

WHEREAS, the Grantors have requested that the Lender release its security interest in all right, title and interest in, to and under the Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Lender hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under the Collateral, including the issued patents, patent applications, trademark registrations, trademark applications and copyright registrations set forth in Exhibit A, Exhibit B and Exhibit C attached hereto and incorporated herein by reference, and agrees that all the security interest in the Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantors, without recourse, representation or warranty, any and all right, title and interest that the Lender may have obtained in, to and under the Collateral under the Loan Agreement and Intellectual Property Security Agreement.


